New Business:

Ulster County Soil & Water Conservation District Executive Director Jake Wedemeyer advised the members that SWCD was awarded \$166,400 by New York State to support a multi-farm initiative aimed at enhancing soil health management. The awarded funds will enable the farms to adopt best management practices (BMPs) such as cover cropping and reduced tillage, both proven strategies for improving soil health, reducing erosion, and increasing organic matter.

Legislator Stewart asked Planning Director questions regarding unclaimed funds/enforcement for non-compliance with the county's short term rental registry.

Planning Director Doyle advised the members of the possibility of a Late Resolution pertaining to a \$1 million federal award to go toward the Golden Hill Housing Project.
