WHEREAS, this resolution has been submitted by the County Executive on behalf of the Ulster County Department of Emergency Communications / Emergency Management; and

WHEREAS, pursuant to Resolution No. 8 dated January 23, 2012, the Chairman of the Ulster County Legislature executed an agreement with the New York State Office of Homeland Security and Emergency Services for FY11 State Homeland Security Program (SHSP) – Anti Terrorism Funds (NYS Contract No. C974110) in the amount of \$38,353.00, for the period September 1, 2011 through August 31, 2014; and

WHEREAS, this contract is a Federally funded program (CFDA# 97.067) to be administered by the New York State Homeland Security and Emergency Services Agency and which requires no matching County funds; and

WHEREAS, the goal of the State Homeland Security Program (SHSP) is to purchase additional hazardous materials response equipment that would enable emergency responders to more safely and efficiently identify hazardous substances and decontaminate individuals exposed to them; and

WHEREAS, to date, the Emergency Communications / Emergency Management Department spent \$15,430.00 of the \$53,783.00 leaving an unexpended balance of \$38,353.00; and

WHEREAS, the Director Emergency Communications / Emergency Management requests that the unexpended funds be appropriated and the 2014 Ulster County Budget be amended accordingly; and
