WHEREAS, Resolution No. 259 dated June 19, 2018, authorized the Chairman of The Ulster County Legislature to Enter into an agreement with the Dormitory Authority Of The State of New York ("DASNY") for project management services – Ulster County Community College, and

WHEREAS, the College and the County are now formally requesting to provide design management services of a DASNY term consultant for design services and to use DASNY staff to manage construction for the Hardenburgh and Vanderlyn Halls Door Replacement Project from the Dormitory Authority of the State of New York, and

WHEREAS, the SUNY Ulster Board of Trustees approved the Work Order No. 2019-002 with the Dormitory Authority of the State of New York (Capital Project: Door Replacement Project) via Resolution #19-02-55, at the Board of Trustees meeting held in February 2019; and
