WHEREAS, this resolution has been submitted at the request of the County Executive on behalf of the County’s Department of Social Services (“DSS”); and

WHEREAS, the DSS has received notification from the Redlich Horwitz Foundation of the award of \$10,000.00 in funding to support the continued implementation of strategies and practices to strengthen the County’s readiness to implement the federal Family First Prevention Services Act (“Family First”); and

WHEREAS, the funds will be used exclusively to enhance the County’s Foster Care program and activities associated with the Family First Readiness Initiative; and

WHEREAS, in order to reflect the increased funding, an amendment of the 2021 Ulster County Budget is necessary; and

WHEREAS, no County contribution or matching funding is required; now, therefore be it
