WHEREAS, the Enterprise West Facility was transferred to the Ulster County Economic Development Alliance, Inc. by deed on the 27th day of May, 2021; and

WHEREAS, Ulster County Economic Development Alliance, Inc. has agreed to enter into a Lease Agreement, as lessor, with the County, as lessee pursuant to the terms and conditions approved by the County Attorney's Office; now, therefore be it
