WHEREAS, UPAC LLC will receive payments totaling the not to exceed amount of \$24,750.00 \$12,375.00, in accordance with the terms specified in an agreement with the County of Ulster and UPAC LLC, and no later than December 31, 2020, UPAC LLC shall submit a certified accounting of expenditures to the Legislative Financial Analyst and Commissioner of Finance; now, therefore, be it

RESOLVED, that the Chair of the Ulster County Legislature is hereby authorized to execute an agreement in the amount of \$24,750.00 \$12,375.00 with UPAC LLC, for various operational expenses that allow Ulster Performing Arts Center to provide programming for Ulster County residents, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney, Counsel to the County Legislature, Chair of the County Legislature, and the Chair and Deputy Chair of the Legislative Programs, Education and Community Services Committee; and, be it further
