Chairman of the Public Works and Capital Projects Committee, Dean J. Fabiano, and Deputy Chairman Peter M. Loughran offer the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Public Works; and

WHEREAS, the Ulster County Legislature has Enacted Local Law No. 3 of 2015; A Local Law Establishing a Sustainable Green Fleet Policy; and

WHEREAS, said law establishes the policy of the County “to purchase ...the most energy efficient and cost effective vehicles possible...;” and

WHEREAS, the law further states “...Ulster County is committed to using electric, hybrid-electric, hybrid and sustainable green vehicles across the fleet;” and

WHEREAS, the Department of the Environment, in consultation with the Ulster County Department of Public Works in response to a rebate/grant program issued by the New York State Department of Environmental Conservation (DEC) for the 2016 Municipal Zero-emission Vehicle (ZEV) & ZEV Infrastructure Rebate Program applied for and was awarded rebates totaling \$15,000 for the purchase of EV vehicles; and

WHEREAS, three qualifying vehicles were purchased; and

WHEREAS, the Department of Public Works requests that the Chairman of the Ulster County Legislature be authorized to enter into the agreement (DEC01-T00255GG-3350000), with the New York State Department of Environmental Conservation (DEC) for the 2016 Municipal Zero-emission Vehicle (ZEV) & ZEV Infrastructure Rebate Program, in the amount of \$15,000; now, therefore, be it
