WHEREAS, Resolution No. 271 of June 20, 2017 amended the 2017 operating budget for \$521,553.00 for participation in the 2016 Statewide Interoperable Communications Grant (SICG) for Land Mobile Radio Systems; and

WHEREAS, Resolution No. 243 of 2018 amended Capital Project No. 482 and provided authorization and funding of \$524,993.00 for the Project, making the project total \$944,993.00; and

WHEREAS, Resolution No. 69 of 2019 amended Capital Project No. 482 and provided authorization and funding of \$575,721.00 for the Project, making the project total \$1,520,714.00; and

WHEREAS, Resolution No. 428 of 2019 amended Capital Project No. 482 and provided authorization and funding of \$477,385.00 for the Project from the 2017 SICG authorized and unused from Resolution No. 271 of June 20, 2017, making the project total \$1,998,099.00; and

WHEREAS, Resolution No. 181 of April 20, 2021 authorized the Chair to execute an agreement with the New York State Division of Homeland Security and Emergency Services for the 2018 Statewide Interoperable Communications Targeted Grant (SICG), for the period beginning March 1, 2021 and ending February 28, 2025, in the amount of \$6,000,000.00; and

WHEREAS, Resolution No. 527 of 2021 amended Capital Project 482 and provided authorization and funding of \$3,150,000.00 for the Project utilizing a portion of the funding authorized in Resolution No. 181 of April 20, 2021, making the project total \$14,186,370.00; and

WHEREAS, Resolution No. 587 of 2021 amended Capital Project 482 and provided authorization and funding of \$2,850,000.00 for the Project to expend the remaining balance of the \$6,000,000 SICG authorized in Resolution No. 181 of April 20, 2021, making the project total \$17,036,370.00; and

WHEREAS, Resolution No. 55 of 2022 amended Capital Project 482 and provided authorization and funding of \$540,609.00 for the Project, making the project total \$17,576,979.00; and

WHEREAS, Resolution No. 568 of 2022 amended Capital Project 482 and provided authorization and funding of \$1,091,873.00 for the Project, making the project total \$18,668,852.00; and

WHEREAS, the 2025-2030 Capital Improvement Program includes \$11,038,064 for fiscal year 2025 for Capital Project No. 482; and

WHEREAS, the Director of Emergency Communications / Emergency Management has received notification from the New York State Division of Homeland Security and Emergency Services regarding the 2024 Statewide Interoperable Communications Grant (SICG); and

WHEREAS, the purpose of this program is to make necessary improvements and provide for sustainment of Land Mobile Radio Systems (LMR), implementation and maintenance of components supporting interoperability, continuous training and exercise, sustainment and further development of the governance structure; and

WHEREAS, the County Executive and the Director of Emergency Communications/Emergency Management requests that the Chair of the Ulster County Legislature be authorized to execute an agreement, and any amendments thereto, with the New York State Division of Homeland Security and Emergency Services for participation in the 2024 Statewide Interoperable Communications Grant (SICG), for the period beginning January 1, 2024 and ending December 31, 2026, in the amount of \$552,845.00; now, therefore be it

RESOLVED, that the Chair of the Ulster County Legislature is hereby authorized to execute an Agreement, and any amendments thereto, with the New York State Division of Homeland Security and Emergency Services for participation in the 2023 Statewide Interoperable Communications Grant (SICG), for the period beginning January 1, 2024 and ending December 31, 2026, in the amount of \$552,845.00 filed with the Clerk of the Ulster County Legislature or as modified by the County Attorney; and, be it further
