WHEREAS, the Ulster County Sheriff's Office is requesting to increase the Ulster County Jail Equipment Replacement Capital Project No. 706 to include the purchase of replacement washers approved in the 2025-2030 Capital Improvement Program; and

WHEREAS, the approved 2025 – 2030 Capital Improvement Program includes a project entitled Jail Kitchen/Laundry equipment in the amount of \$760,468.00; and

WHEREAS, it is necessary to fund the 2025 Capital Fund program in addition of the amount \$20,550.00 for said purchases; now, therefore, be it
