WHEREAS, this resolution has been submitted at the request of the Ulster County Sheriff; and

WHEREAS, the 2025-2030 Ulster County Capital Improvement Plan included funding for Law Enforcement Equipment; and

WHEREAS, Resolution No. 720, dated December 17, 2024 established Capital Project No. 710 in the amount of \$74,542.00 for the purchase of Marine Sonic ARC Explore MKII system; and

WHEREAS, the 2025-2030 Ulster County Capital Improvement Plan includes funding of \$200,000.00 for Law Enforcement Equipment for fiscal year 2025; and

WHEREAS, the Ulster County Sheriff's Office is requesting to increase the Law Enforcement Equipment Capital Project No. 710 to include the purchase of replacement Law Enforcement Equipment approved in the 2025-2030 Capital Improvement Plan in the amount of \$200,000.00; and

WHEREAS, Capital Project No. 710 will purchase ATVs, a UTV, Jet Skis, Mountain bikes and trailers; and

WHEREAS, it is necessary to fund the 2025-2030 Ulster County Capital Improvement Program in addition of the amount \$88,315.00 for said purchases with a possible 20% increase contingency, making the project total cost \$288,315.00; now, therefore be it
