WHEREAS, the Ulster County Sheriff's Office Dispatch currently operates on the County's main phone system (VOIP phone system); and

WHEREAS, it is necessary to ensure un-interrupted coverage to the Sheriff's Dispatch operation in the same manner as service is provided to the E-911 phone system; and

WHEREAS, to upgrade Sheriff's dispatch phone system to match the E-911 call handling platform it is necessary to upgrade the Sheriff's Dispatch to the Vesta 911 Remote Add to match Emergency Managements and provide better service to the Ulster County residents; and

WHEREAS, the Ulster County Sheriff is requesting to establish Capital Project No. 731 to upgrade the Sheriff's Dispatch phone operation; and

WHEREAS, the Ulster County Sheriff has obtained quotes for Vesta 911 Remote Add in the amount of \$188,972.00; and

WHEREAS, with the addition of contingency for unanticipated costs of \$18,897.00; now, therefore be it
