WHEREAS, this resolution has been submitted at the request of the County Executive on behalf of the Department of Probation; and

WHEREAS, the Ulster County Department of Probation has received notification from the New York State Office of Children and Family Services (OCFS) of increased funding for Family Violence Prevention and Services Act (FVPSA) American Rescue Plan (ARP) Rape Crisis and Sexual Assault Programs Supplemental COVID-19 Grant per notification dated February 27, 2025; and

WHEREAS, to reflect the increased funding, an amendment of the 2025 budget is necessary; and

WHEREAS, there is no increase in the County contribution as a result of these modifications; now therefore, be it
