

Authorizing The Chairman Of The Ulster County Legislature To Execute An Agreement With Arts Mid-Hudson For The 2018 Appropriation – Legislature

Chairman of the Legislative Programs, Education and Community Services Committee, David B. Donaldson, and Deputy Chair Heidi Haynes, offer the following:

WHEREAS, performing arts are an important component of our cultural heritage, and the many performances arranged by Arts Mid-Hudson attract County residents as well as travelers to see a broad range of entertainment for the community; and

WHEREAS, pursuant to County Law Section 224 (13), the Ulster County Legislature appropriated to Arts Mid-Hudson the sum of \$77,500.00 in the 2018 Ulster County Budget for the purpose of working in partnership with Ulster County to promote the arts and cultural heritage supporting the efforts to promote the County as a destination for cultural tourism; and

WHEREAS, pursuant to County Law Section 224 (13), in order to receive such funds, Arts Mid-Hudson must submit to the Ulster County Legislature a verified accounting of disbursements to be undertaken, and to the Ulster County Commissioner of Finance, a Memorandum of Receipt signed by the principal officer; and

WHEREAS, Arts Mid-Hudson will receive payment in the amount of \$77,500.00, in accordance with the terms specified in an agreement with the County of Ulster and Arts Mid-Hudson and will return any unexpended funds as of December 31, 2018 along with a certified accounting of expenditures to the Commissioner of Finance; now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an Agreement in the amount of \$77,500.00 with Arts Mid-Hudson, to work in partnership with Ulster County, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney, Counsel to the County Legislature, Chairman of the County Legislature, and the Chairman and Deputy Chairman of the Legislative Programs, Education and Community Services Committee; and, be it further
