Chairwoman of the Law Enforcement and Public Safety Committee, Eve Walter, and Deputy Chair Heidi Haynes offer the following:

WHEREAS, this resolution has been submitted by the Sheriff’s Office; and

WHEREAS, this resolution is requesting authorization to apply for the Department of Homeland Security Grant-Port Security Grant Program-FEMA to purchase and install an upgraded navigation system to comply with the Coast Guard Maritime requirements; and

WHEREAS, the total program funding is \$25,000.00 with an award ceiling of \$100,000.00; and

WHEREAS, the approval to apply for this grant will provide the Sheriff’s Office an opportunity to upgrade a navigation system that is 12 years old and outdated to meet Coast Guard standards; and

WHEREAS, the funds will purchase and install a new navigation system for approximately \$25,000.00 with 100% reimbursement; and

WHEREAS, it is necessary to apply for this grant by May 30, 2020, or risk losing this opportunity; now, therefore be it

RESOLVED, that the Chair of the Ulster County Legislature is hereby authorized to execute the application for the Department of Homeland Security Grant-Port Security Grant Program- FEMA,

and move its adoption.
