WHEREAS, this resolution has been submitted by the County Executive on behalf of the Ulster County Department of Emergency Communications / Emergency Management; and

WHEREAS, the Director of Emergency Communications / Emergency Management has received notification from the New York State Division of Homeland Security and Emergency Services regarding the State Fiscal Year 2013-2014 Public Safety Answering Point Sustainment Grant; and

WHEREAS, the purpose of this program is to facilitate the development, consolidation, and improved operations of public safety answering points; and

WHEREAS, the Director of Emergency Communications / Emergency Management requests that the Chairman of the Ulster County Legislature be authorized to enter into an agreement (NYS Contract# C198425), and any amendments thereto, with the New York State Division of Homeland Security and Emergency Services for the contract period June 25, 2014 through June 24, 2015, in the amount of \$89,253.00; now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an Agreement (NYS Contract# C198425), and any amendments thereto, with the New York State Division of Homeland Security and Emergency Services for participation in the Public Safety Answering Point Sustainment Grant for State Fiscal Year 2013-2014, in the amount of \$89,253.00, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney; and, be it further
