WHEREAS, Onteora Central School District will pay Ulster County an amount not less than \$97,018.00 for the services of an existing full-time Deputy Sheriff assigned as the School Resource Officer; and

WHEREAS, the term of the agreement shall begin September 1, 2019 and end June 30, 2020; now, therefore, be it

RESOLVED, that the Chair of the Ulster County Legislature is hereby authorized to execute an agreement and any related amendments with the Onteora Central School District to provide a Deputy Sheriff to serve as a School Resource Officer for the term beginning September 1, 2019 and ending June 30, 2020, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney, in consultation with Counsel to the County Legislature, Chair of the County Legislature, and the Chair and Deputy Chair of the Law Enforcement and Public Safety Committee,

and move its adoption.
