Chairman Craig Lopez promptly called the meeting to order at 6:30 PM.

MOTION NO. 1 To Approve the Minutes of the March 2, 2015 Meeting

Michael Iapoce, Commissioner Department Social Services - Medicaid Reimbursement Claims:

An OIG audit was performed by the U.S. Federal Department of Health and Human Services Office of the Inspector General on Ulster County's Medicaid reimbursements for "continuous 24-hour personal care", and it was determined the state improperly claimed Medicaid reimbursements for all (30) of the Ulster County claims submitted between 2008 to 2011, and noted (14) of them had more than one deficiency. The final report determined the lack of independent medical review of each claim was not adhered to thus did not meet state regulations. Ulster County submits their claims to the state, which in turn submits their claims to the federal government. The elderly, disabled and those with chronic or temporary conditions use these services.

Chairman Lopez asked Commissioner Iapoce for his position on the report, where the county stands, and what action the county plans to take going forward to comply with the Medicaid program requirements. Committee discussion ensued.

Commissioner Iapoce confirmed:

- Several audits have been done throughout the State of New York can be viewed on line
- The OIG audit covered years 2008 2011
- The audit is between the state and federal government
- The federal government is monitoring the New York State program at the district level
- The findings were sent to the state for state compliance not Ulster County
- No one has contacted the county including OIG and OMEG for information, comments or directives
- Ulster County is in compliance with the state who oversees our conduct
- At this particular stage the county has not become a party to the audit
- The state is in the process of taking over the administration of the Medicaid program already in year four of a six year takeover plan
- The OIG has not requested we make any changes
- No Plan to modify the procedure currently in place
- Ouality of service provided is not in question
- Lack of doctor review/approval of claims program compliance
- Services not entitled to refers to program compliance

Chairman Lopez asked Commissioner Iapoce to please keep the committee informed going forward once they hear more from the state or federal government regarding the audit results.

Minerva Solla, New York State American Nurses Association (ANA) Rep., 243 Wall St. Kingston:

Chairman Lopez introduced Ms. Minerva Solla who came before the committee to promote awareness and ask for support via resolution for the "Safe Staffing for Quality Care Act" bills introduced both in the Assembly A1548 January 12, 2015, and Senate S782 January 7, 2015. Both bills were provided with the committee agenda. Ms. Solla provided the Chairman with literature for the record. The ANA supports the Registered Nurse Safe Staffing Act which would require Medicare participating hospitals, through a committee comprised of at least 55% direct care nurses or their representatives, establish and publicly report staffing plans. Committee discussion ensued.

- Local chapter in Kingston
- NYS Nurses Association represents 37,000 nurses
- The bill has bipartisan support sponsored by a republican in senate, and democrat in assembly
- Schenectady County passed a resolution supporting the Safe Staffing Act
- Establish adjustable minimum numbers of RN's per patient ratio currently 8 to 1 (4-1 preferred)
- Include input from direct care RNs
- Be based upon patient numbers & the variable intensity of care needed
- Take into account level of education, training and experience
- Take into account staffing levels provided by other health care personnel associated w/nursing care
- Consider staffing levels recommended by specialty nursing organizations
- Take into account unit and facility level staffing, patient outcome data & national comparisons
- Take into account unit geography and available technology
- Ensure RNs are not forced to work in units where they are not trained or experienced
- Adding RN's to unit staffing has been shown to eliminate almost 1/5 of all hospital deaths
- Reducing medical errors will prevent payment denial for preventable hospital acquired injuries or illnesses
- Increase staffing will induce positive work environment
- Retention of nurses reduce recruitment and retraining costs
- Avoidable extra stay days for adverse patient events infection and bleeding saves millions of dollars
- Staffing increases will inflate facility costs

Although Legislator Belfiglio is in support of a memorializing resolution, he noted the state needs to address the inequities regarding the reimbursement system throughout the counties – Ulster County receives less than neighboring counties.

Chairman Lopez and committee members thanked Ms. Solla for coming before the committee and will be in touch regarding a potential future resolution showing support.

Discussion: Legislator Belfiglio asked about same services being provided by

> different vendors and cost ratios. Legislative Counsel Erica Guerin noted all the contracts are the same and stated different vendors are needed to cover different locations throughout the county. Some discussion ensued to better understand the contracts. Legislator Belfiglio shared his concerns to better understand the children age groups and special needs of children and community needs. These are

state mandated programs.

Note: Prior to the meeting Leg. Belfiglio emailed Ken Crannell asking how much over \$50K are the contracts and why don't we know the rates? Also, how do we make sure each vendor is in compliance with

the law as it pertains to their area of expertise?

Ken's response – Projections are based on historical data. provided a list of vendors whose contracts need to be renewed that

have been paid thus far in the 2014-15 school year.

<u>PreK over \$50K</u> – We only pay the rates identified for each related service or evaluation provided. Tuition rates which are set by NYS Dept of Education are not identified within the contract, but are available on the NYSED website: http://eservices.nysed.gov/netrates/index.jsp

<u>Preschool Schedule B rates</u> – In regards to the compliance question, we monitor that all vendors are properly licensed for their area of expertise, and are registered with the NYS Dept. of Education and/or the NYS Dept. of Health, which oversees this program. Providers may not operate within these programs, nor will they be contracted with, until they are approved by NYSED and/or NYSDOH. Registrations and approvals are monitored by the DSS Preschool unit.
