**Resolution Summary** –This Resolution approves the execution of a contract amendment in the amount of \$9,900.00 with Inter-Fluve Engineering, P.L.L.C. to extend term of agreement and expand scope of services to include additional meetings, comments ad outreach related to the development of a Stream Management Plan for the Lower Esopus Creek, flowing through the Towns of Olive, Marbletown, Hurley, Ulster, Saugerties as well as the City of Kingston and the Village of Saugerties.
