WHEREAS, pursuant to Section C-26(B) of the Ulster County Charter and Section A3-5(B) of the Administrative Code: "Appointment of department heads. The appointment by the County Executive of the head of each department or other administrative unit shall be subject to the confirmation by the County Legislature by vote of a majority of the whole number of members elected to that body, taken at a regular or special meeting;" and

WHEREAS, pursuant to aforementioned sections of the Ulster County Charter and the Administrative Code, the County Executive has appointed Carolyn Hargrove to the position of Director of the Department of Public Transportation for the County of Ulster; now, therefore, be it

RESOLVED, that the Ulster County Legislature hereby confirms the appointment of Carolyn Hargrove to the position of Director of the Department of Public Transportation for the County of Ulster,
