WHEREAS, this resolution has been submitted at the request of the County Executive on behalf of the Department of Finance, Division of Recovery and Resilience; and

WHEREAS, the Ulster County Legislature passed Resolution No. 96 amending and funding Capital Project No. 604 in the amount of \$5,000,000 to create a program to partner with Ulster County municipalities and match up to 33% of water and sewer projects with a maximum contribution of \$500,000 per project; and

WHEREAS, the County and the Town of New Paltz (the "Town") desire to enter into an Intermunicipal Agreement (IMA) where the Town will be a subrecipient of \$500,000.00 of American Rescue Plan Act – Coronavirus State and Local Fiscal Recovery Funds (SLFRF); and

WHEREAS the Town will be responsible under the IMA for administering a program to interconnect its Sewer District 6 with the Village of New Paltz sewer system; now, therefore, be it

RESOLVED, the Chair of the Ulster County Legislature is hereby authorized to execute the IMA with the Town to fund infrastructure for interconnection of a Town sewer district in the form as filed with the Clerk of the Legislature or as modified with the approval of the County Attorney,

and move its adoption.
