WHEREAS, this resolution has been submitted at the request of the County Executive on behalf of the Department of Finance, Division of Recovery and Resilience; and

WHEREAS, the Ulster County Legislature passed Resolution No. 96 amending and funding Capital Project No. 604 in the amount of \$5,000,000 to create a program to partner with Ulster County municipalities and match up to 33% of water and sewer projects with a maximum contribution of \$500,000 per project; and

WHEREAS, the County and the Village of New Paltz (the "Village") desire to enter into an Intermunicipal Agreement (IMA) where the Village will be a subrecipient of \$500,000.00 of American Rescue Plan Act – Coronavirus State and Local Fiscal Recovery Funds (SLFRF); and

WHEREAS the Village will be responsible under the IMA for administering a program to replace the water main infrastructure along North and South Chestnut Streets; now, therefore, be it

RESOLVED, the Chair of the Ulster County Legislature is hereby authorized to execute the IMA with the Village of New Paltz to fund the replacement of Village water main infrastructure in the form as filed with the Clerk of the Legislature or as modified with the approval of the County Attorney,

and move its adoption.
