WHEREAS, this Resolution has been submitted at the request of the County Executive on behalf of the Department of Health (DOH); and

WHEREAS, the Ulster County Department of Health has received notification from the New York Department of Health of an allocation of \$23,286.00 for participating in the Local Health Department Performance Incentive Program; and

WHEREAS, the funds are intended to be used exclusively to support costs associated with eligible services pursuant to New York State Public Health Law Article 6; and

WHEREAS, the funds will be used to develop and promote a marketing campaign that will bring awareness to preventing chronic disease through physical activity; and

WHEREAS, the area of focus will be the City of Kingston, as they were a key collaborative partner in securing the incentive; and

WHEREAS, in order to reflect this, an amendment of the 2025 budget is necessary; now, therefore be it
