WHEREAS, pursuant to Section C-11(O) of the Ulster County Charter and Section A2-5(15) of the Administrative Code, the Ulster County Legislature shall have the power to approve the execution of certain contracts and amendments in the amount of \$50,000.00 or in excess of \$50,000.00 entered into by the County; and

WHEREAS, a contract for execution by the County with Culjak, Kristen has been submitted for approval by the Ulster County Legislature, which is described below:

2017-00000210 - Two year Agreement to provide Preschool Special Education and related services to children with disabilities, ages 3 through 5, in accordance with Section 4410 of NYS Education Law and in compliance with Part 200 of the Regulations of the NYS Commissioner of Education. Services include Speech Pathology, Speech Therapy, Occupational Therapy, etc. The services provided are regulated by NYS, paid in accordance with NYS set rates, & providers are licensed & approved through NYS.
