WHEREAS, the Summer Recreation Program has as an objective, helping youth demonstrate ethical behavior and civic values, and the Program provides a safe, structured out of school time environment for youth; and

WHEREAS, Ulster County will be reimbursed \$1,100.00 attributable to the program by the New York State Office of Children and Family Services in accordance with the Youth Bureau's 2014 Resource Allocation Plan; now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an agreement, and any amendments thereto, for the Summer Recreation Program with the Town of Hurley, for the term January 1, 2014 through December 31, 2014, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney; and be it further
