WHEREAS, the Job Placement Program has as an objective, helping youth obtain employment opportunities, and gain job readiness skills; and

WHEREAS, Ulster County will be reimbursed \$3,900.00 attributable to the program by the New York State Office of Children and Family Services in accordance with the Youth Bureau's 2014 Resource Allocation Plan; now, therefore, be it
