Chairman of the Legislative Programs, Education and Community Services Committee, David B. Donaldson, and Deputy Chairman Mary Wawro offer the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Director of the Youth Bureau; and

WHEREAS, New York State's General Municipal Law Article 5-G and Section A3-4 (Y) of the Ulster County Administrative Code provide that the Chairman of the Ulster County Legislature can enter into an inter-municipal agreement on behalf of the County of Ulster; and

WHEREAS, the Director of the Youth Bureau and the Ulster County Youth Board join in requesting that the Chairman of the Ulster County Legislature be authorized to execute an agreement for the Summer Recreation Program and Youth Employment Referral Service with the Town of Rochester in the amount of \$1,400.00, for the term January 1, 2014 through December 31, 2014; and

WHEREAS, the Summer Recreation Program has as an objective, helping youth demonstrate ethical behavior and civic values, and the Program provides a safe, structured out of school time environment for youth; and

WHEREAS, the Youth Employment Referral Service has as an objective, helping youth obtain employment opportunities, and gain job readiness skills; and

WHEREAS, Ulster County will be reimbursed \$1,400.00 attributable to the program by the New York State Office of Children and Family Services in accordance with the Youth Bureau's 2014 Resource Allocation Plan; now, therefore, be it
