RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to sign an agreement, and any amendments thereto, with the Rondout Valley Central School District to provide two Deputy Sheriffs to serve as a School Resource Officers for the term September 1, 2018 through June 30, 2019, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney in consultation with the Chairman of the Legislature and the Chair and Deputy Chair of the Law Enforcement and Public Safety Committee; and, be it further

RESOLVED, that if funding for this program is eliminated, the program/positions will be eliminated as well,

and moves its adoption.
