WHEREAS, this resolution has been submitted at the request of the County Executive on behalf of the Department of Finance; and

WHEREAS, pursuant to Section 1442 of the New York State Real Property Tax Law, Ulster County may provide for collection of delinquent village taxes, if such collection is requested by resolution of the board of trustees of any village within such county; and

WHEREAS, Local Law No. 5 of 2022 authorizes the Chair of the Ulster County Legislature to enter into agreements with the Villages of Ellenville, New Paltz, and Saugerties relating to the collection of delinquent taxes on real property following the submission of such request from the board of trustees; and

WHEREAS, on February 5, 2024, the Village of Saugerties Board of Trustees authorized the Mayor of Saugerties to enter into an agreement with the Ulster County Commissioner of Finance to provide for the collection of such delinquent taxes pursuant to Local Law No. 5 of 2022; now therefore, be it

RESOLVED, that the Chair of the Ulster County Legislature is hereby authorized to enter into an agreement with the Village of Saugerties, relative to the collection of delinquent village taxes pursuant to Local Law No. 5 of 2022,

and moves its adoption.
