WHEREAS, the County Executive has submitted this resolution on behalf of the Department of Public Works; and

WHEREAS, the Commissioner of Public Works has been notified by the New York State Department of Transportation of a decrease in CHIPS funding for Ulster County Highway Capital Improvements in the amount of \$3,464.15 for the State fiscal year 2017-2018; and

WHEREAS, there exists a 2016 CHIPS budget balance of \$376,702.03 to be rolled over into the 2017 Budget; and

WHEREAS, it is necessary to adjust the Budget to reflect the net difference of the rollover balance and State decrease in funding; and

WHEREAS, the Commissioner of Public Works requests the 2017 CHIPS appropriations and revenues be increased by \$373,237.88 (\$376,702.03 rollover minus \$3,464.15 decrease); and
