WHEREAS, the term of the agreement shall be July 7, 2025 through August 15, 2025; now, therefore, be it

RESOLVED, that the Chair of the Ulster County Legislature is hereby authorized to sign an agreement, and any amendments thereto, with Ulster County BOCES to provide one Deputy Sheriff to serve as a School Resource Officer for the term July 7, 2025 through August 15, 2025, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney,
