Authorizing The Issuance Of An Additional \$1,200,000.00 Bonds To Pay Part Of The Cost Of The Reconstruction Of The SUNY Ulster Children's Center In And For The County Of Ulster, New York, In And For Said County

Chairwoman of the Economic Development, Planning, Education, Employment, Arts and Agriculture Committee, Megan Sperry, and Deputy Chair Herbert Litts, III offer the following:

WHEREAS, by Resolution No. 284 dated and duly adopted on the date hereof, the County Legislature of the County of Ulster, New York has amended Capital Project No. 624 for reconstruction of SUNY Ulster Children's Center; and

WHEREAS, the County Legislature of the County of Ulster, New York, on March 16, 2022, duly adopted a bond resolution authorizing the issuance of \$40,000.00 bonds of said County to pay the cost thereof, and

WHEREAS, the County Legislature of the County of Ulster, New York, on March 19, 2024, duly adopted a bond resolution authorizing the issuance of \$10,000.00 bonds of said County to pay the cost thereof, and

WHEREAS, the capital project hereinafter described, as proposed, has been determined to be a Type II Action pursuant to the regulations of the New York State Department of Environmental Conservation promulgated pursuant to the State Environmental Quality Review Act, which regulations state will not have any significant adverse impact upon the environment; and

WHEREAS, it has now been determined that the maximum estimated cost of said capital project is \$1,250,000.00, an increase of \$1,200,000.00 over that previously authorized for the planning thereof; and

WHEREAS, it is now desired to authorize the issuance of an additional \$1,200,000.00 bonds of said County to pay a portion of the cost thereof; now, therefore be it

RESOLVED, by the affirmative vote of not less than two-thirds of the total voting strength of the County Legislature of the County of Ulster, New York, as follows:

- Section 1. The reconstruction of the SUNY Ulster Children's Center in and for the County of Ulster, New York, including original furnishings, equipment, machinery, apparatus, appurtenances, and incidental improvements and expenses in connection therewith, are hereby authorized at a new maximum estimated cost of \$1,250,000.00.
- Section 2. It is hereby determined that the plan for the financing of said maximum estimated cost is as follows:
- a) by the issuance of the \$40,000.00 bonds of said County authorized to be issued pursuant to bond resolution dated and duly adopted March 16, 2022;
- b) by the issuance of the \$10,000.00 bonds of said County authorized to be issued pursuant to bond resolution dated and duly adopted March 19, 2024; and
- c) by the issuance of an additional \$1,2000,000.00 bonds of said County hereby authorized therefor to be issued pursuant to the provisions of the Local Finance Law.
- Section 3. It is hereby determined that the period of probable usefulness of the aforesaid specific object or purpose is twenty-five years, pursuant to subdivision 12(a)(1) of paragraph a of Section 11.00 of the Local Finance Law, calculated from the date of issuance of the first obligations for said class of objects or purposes. The period of probable usefulness of the preliminary design expenses provided in the bond resolutions adopted March 16, 2022 and March 19, 2024 is hereby determined to be twenty-five years as provided herein, and said bond resolutions are hereby amended to so provide.
- Section 4. Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the bonds herein authorized, including renewals of such notes, is hereby delegated to the Commissioner of Finance, the chief fiscal officer. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said Commissioner of Finance, consistent with the provisions of the Local Finance Law.

Section 5. All other matters except as provided herein relating to the serial bonds herein authorized including the date, denominations, maturities and interest payment dates, within the limitations prescribed herein and the manner of execution of the same, including the consolidation with other issues, and also the ability to issue serial bonds with substantially level or declining annual debt service, shall be determined by the Commissioner of Finance, the chief fiscal officer of such County. Such bonds shall contain substantially the recital of validity clause provided for in Section 52.00 of the Local Finance Law, and shall otherwise be in such form and contain such recitals, in addition to those required by Section 51.00 of the Local Finance Law, as the Commissioner of Finance shall determine consistent with the provisions of the Local Finance Law.

Section 6. The faith and credit of said County of Ulster, New York, are hereby irrevocable pledged for the payment of the principal of and interest on such bonds as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such bonds becoming due and payable in such year. There shall annually be levied on all the taxable real property of said County, a tax sufficient to pay the principal of and interest on such bonds as the same become due and payable.

Section 7. The validity of such bonds and bond anticipation notes may be contested only if:

- 1) Such obligations are authorized for an object or purpose for which said County is not authorized to expend money, or
- 2) The provisions of law which should be complied with at the date of publication of this resolution are not substantially complied with,

and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or

- 3) Such obligations are authorized in violation of the provisions of the Constitution.
- Section 8. This resolution shall constitute a statement of official intent for purposes of Treasury Regulations Section 1.150 2. Other than as specified in this resolution, no monies are, or are reasonably expected to be, reserved, allocated on a long term basis, or otherwise set aside with respect to the permanent funding of the object or purpose described herein.
