WHEREAS, this resolution has been submitted at the request of the County Executive on behalf of SUNY Ulster; and

WHEREAS, Resolution No. 684, dated December 6, 2023, approved the advancement of capital projects for the Ulster County Community College that were included in the approved 2024-2029 Ulster County Capital Improvement program; and

WHEREAS, due to the aging infrastructure SUNY Ulster is in the need of funding set up for handling minor critical maintenance; and

WHEREAS, the \$500,000 cost to for handle minor critical maintenance in 2024, would be divided as follows: \$250,000 State and 250,000 Ulster County; and

WHEREAS, the 2024-2029 Ulster County Capital Improvement Program included funding of \$500,000 for Minor Critical Maintenance; now, therefore be it
