

Authorizing The Chairman Of The Ulster County Legislature To Enter Into A Lease Agreement With Hudson Valley Mental Health, Inc. To Provide Office Space At Trudy Farber Resnick Center—Department Of Public Works (Buildings and Grounds)

Chairman of the Public Works and Capital Projects Committee, Dean J. Fabiano, and Deputy Chairman John Parete offer the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Public Works; and

WHEREAS, Ulster County has entered into an agreement with Hudson Valley Mental Health, Inc. (HVMH) wherein HVMH will provide direct mental health services to Ulster County residents; and

WHEREAS, in order to promote continuity of care, Ulster County has offered to lease to HVMH space at the same locations where the County provided those services to clients; and

WHEREAS, HVMH will pay to the County rent payable in monthly installments as per the terms of the lease agreement; and

WHEREAS, the Commissioner of Public Works requests the Chairman of the Ulster County Legislature be authorized to enter into a lease agreement with HVMH, for a five-year term commencing January 1, 2014 and ending December 31, 2018, at an annual rent of \$30,930.00 (\$10.00 per square foot), with all utilities and taxes included; now, therefore be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to enter into a lease agreement, and any amendments thereto, with Hudson Valley Mental Health, Inc. for a five-year term commencing January 1, 2014 and ending December 31, 2018, at an annual cost of \$30,930.00 (\$10.00 per square foot) in the form as filed with the Clerk of the Legislature, or as modified with the approval of the County Attorney,

and moves its adoption.
