WHEREAS, the CARES act grant program previously approved and funded by the Legislature has expended all available funds and has demonstrated a broader need by the small businesses in Ulster County;

WHEREAS, $\$ 1,000,000.00$ is currently needed as funding for funding Round 2 of the "Ulster County Cares Small Business Assistance Program;" and

WHEREAS, pursuant to the amended adopted contact with Ulster County Economic Development Alliance, Inc., the scoring committee shall consist of representation of the Ulster County Executive's office to be appointed by the County Executive, and no less than two (2) members of the Ulster County Legislature to be appointed by the Chair of the Legislature; now, therefore, be it
