WHEREAS, the term of the agreement shall be September 1, 2023 through June 30, 2024; now, therefore be it

RESOLVED, that the Chair of the Ulster County Legislature is hereby authorized to sign an agreement, and any amendments thereto, with the Onteora Central School District to provide a Deputy Sheriff to serve as a School Resource Officer for the term September 1, 2023 through June 30, 2024, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney and Chair of the Ulster County Legislature,

and move its adoption.
