Chair Hewitt called the meeting to order at 2:04 PM.

Chair Hewitt stated the purpose of the Special Meeting of the Energy, Environment and Sustainability Committee is for interviewing and scoring candidates to make a recommendation to the Chair of the Legislature for consideration of appointment to the Ulster County Resource Recovery Agency (UCRRA) Board of Directors.

Chair Hewitt explained to the Committee that interviews have been allotted 15 minutes per applicant, the committee has agreed upon seven (7) standard questions, and each of the Committee Members will take turns asking a question. Members were provided with scoring sheets and asked to complete their scoring sheets at the conclusion of each interview. Members were informed that discussion will take place in Executive Session and afterwards, the Committee will agree to a recommend top candidates which will be best suited for submission to the Chair of the Legislature, who will make the final decision to appoint to the UCRRA Board of Directors for the two (2) seats that are available.

The following questions were asked of the interviewees:

1. Please tell us a little bit about yourself, why you want to serve on UCRRA Board, and what strengths you would bring to it?

2. In 2020 UCRRA adopted a 10-year Local Solid Waste Management Plan, which was approved by the Legislature in 2021.

2a. Have you looked at the plan, which recommended closing and capping landfills, waste reduction and recycling, removing Household Hazardous Waste, and exporting the residual to existing landfills?

2b. How do you envision the UCRRA's role in the program?

2c. It also recommended feasibility studies to site a landfill and to reduce solid waste through a variety of zero waste initiatives. Have you looked at the Cornerstone or HydroQuest studies?

3. Are you in favor of citing a landfill for Ulster County, and if so, how should the agency go about it?

4. What is your vision for the future of solid waste in Ulster County for the next decade and beyond and how might this be implemented?

5. We are in the process of implementing a Zero Waste Implementation Plan – What is your vision for maximum waste diversion?

6. Can you make weekday meetings in the evening? The current UCRRA board has set the 2<sup>nd</sup> Thursday of the month at 6:15 PM for 2025 -- that could be amended, but how will that work for you?

7. Would you be interested in and able to serve on the Recycling Oversight Committee, if not appointed to the UCRRA Board?
