WHEREAS, local municipalities have been invited to participate in URGENT and have been given a Cooperative Agreement for execution to formalize their participation; and

WHEREAS, the Town of Lloyd, by resolution dated November 19, 2014, approved the Town's participation in URGENT and authorized the Town Supervisor to execute the Cooperative Agreement with the County; and

WHEREAS, the Town of Marlborough, by resolution dated October 27, 2014, approved the Town's participation in URGENT and authorized the Town Supervisor to execute the Cooperative Agreement with the County; and

WHEREAS, the Town of Plattekill, by resolution dated November 5, 2014, approved the Town's participation in URGENT and authorized the Town Supervisor to execute the Cooperative Agreement with the County; and

WHEREAS, the Town of Shandaken, by resolution dated November 6, 2014, approved the Town's participation in URGENT and authorized the Town Supervisor to execute the Cooperative Agreement with the County; and

WHEREAS, the Village of Ellenville, by resolution dated October 27, 2014, approved the Village's participation in URGENT and authorized the Mayor to execute the Cooperative Agreement with the County; and

and move its adoption.
