WHEREAS, this resolution has been submitted at the request of the County Executive on behalf of the Department of Social Services; and

WHEREAS, the Department of Social Services has received notification from the New York State Office of Children and Family Services (OCFS) of the availability of additional federal funds through the American Rescue Plan Act of 2021: Grants to Enhance Adult Protective Services administered by the Administration for Community Living (ACL); and

WHEREAS, the County will use the funds to enhance, improve, and expand the ability of APS to investigate allegations of abuse, neglect, and exploitation of vulnerable adults; and

WHEREAS, in order to reflect the increased funding an amendment of the 2022 budget is necessary; and

WHEREAS, no County contribution or matching funding is required; now, therefore, be it
