**Approving The Execution Of A Contract In Excess Of \$50,000.00 Entered Into By The County – Rolling V Bus Corp – Department Of Social Services**

Chairman of the Public Health and Social Services Committee, Craig V. Lopez, and Deputy Chairman Jeanette Provenzano offer the following:

WHEREAS, pursuant to Section C-11(O) of the Ulster County Charter and Section A2-5(15) of the Administrative Code, the Ulster County Legislature shall have the power to approve the execution of certain contracts and amendments in the amount of \$50,000.00 or in excess of \$50,000.00 entered into by the County; and

WHEREAS, a contract for execution by the County with Rolling V Bus Corp has been submitted for approval by the Ulster County Legislature, which is described below:

Department of Social Services	Rolling V Bus Corp	2015-0000422 - Three year Agreement to provide mandated transportation for preschool children with special needs who are receiving mandated services through the County's Preschool programs. These services are being awarded pursuant to a bid to the three lowest bidders. Vendors will be paid at rates pursuant to the bid.
