WHEREAS, a Project for the Lucas Turnpike Shoulder Improvements in the Town of Rochester, PIN 8761.77 (the "Project") is eligible for funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs such program to be borne at the ratio of 80% Federal funds and 20% non-federal funds; and

WHEREAS, the Project may become eligible for New York State Marchiselli Aid, and if this aid becomes available, then Ulster County's financial obligation to the Project will be diminished from its present 20% share; and

WHEREAS, the Project was approved by the Ulster County Transportation Council in the 2016 - 2020 Transportation Improvement Program; and

WHEREAS, the Project will construct four (4) foot wide asphalt shoulders on both sides of Lucas Turnpike from NYS Route 209 to Kyserike Road; and

WHEREAS, Ulster County desires to advance the Project by making a commitment of 100% of the non-federal share of the costs of preliminary engineering and right of way incidentals; and

WHEREAS, the Commissioner of Public Works requests funds for the preliminary engineering and right-of-way incidentals for the Project in the amount of \$38,000.00; and

WHEREAS, based upon examination by the Ulster County Legislature, the County's funding of this Project constitutes a Type II action as defined under Sections 4.5.6 of the County of Ulster's State Environmental Quality Review Act (SEQRA) Type II List, which was adopted pursuant to Resolution No. 118 dated April 20, 2010; and
