WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Public Works; and

WHEREAS, the lease for office space used by the Ulster County Family Court and Public Defender and located at 16 Lucas Avenue, Kingston is set to expire August 31, 2014; and

WHEREAS, the Commissioner of Public Works has requested to renew the lease for a one year term, with a one year option, commencing September 1, 2014 and ending August 31, 2015, at the same annual cost of \$201,600.00; now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to enter into a lease, and any amendments thereto, with GD Realty Kingston, LLC, for office space located at 16 Lucas Avenue, Kingston, New York, to be used to house the Ulster County Family Court and Public Defender, in the form as filed with the Clerk of the Ulster County Legislature or as modified and approved by the County Attorney,

and move its adoption.
