WHEREAS, pursuant to General Municipal Law, Section 119-n(a), the definition of a municipal corporation includes a board of cooperative educational services; and

WHEREAS, the Director of the Department of Employment and Training requests that the Director and Deputy Director of the Department of Employment and Training and the Commissioner of Social Services be authorized by the Legislature to execute a OneStop Consortium Agreement, and any amendments, thereto, with the New York State Department of Labor and Ulster County BOCES; and

WHEREAS, the OneStop Operator Agreement between the Ulster County Workforce Development Board and the Ulster Works Career Center OneStop Consortium outlines the responsibilities of the Consortium as the OneStop Operator under the purview of the Ulster County Workforce Development Board and the guidelines outlined in The Workforce Innovation and Opportunity Act; now, therefore, be it

RESOLVED, that the Director and Deputy Director of the Department of Employment and Training the Commissioner of Social Services are authorized to execute a OneStop Consortium Agreement, and any amendments thereto, with the New York State Department of Labor and Ulster County BOCES, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney,
