WHEREAS, the project expenditures in the amount of \$5,000,000.00 for the Courthouse Fascia, Exterior Repairs & Roof Replacement, were approved in the 2021 – 2026 Capital Program; and

WHEREAS, the Commissioner of Public Works requests that Capital Project No. 595 be established and funded for design work; now, therefore be it
