WHEREAS, the project will increase operational efficiencies, energy conservation and improve ventilation where required; and

WHEREAS, project expenditures in the amount of \$2,500,000.00 for HVAC/Weatherization Project – Various County Buildings, were approved in the 2015 – 2020 Capital Program; and

WHEREAS, it may be necessary for the Commissioner of Finance to transfer funds between these projects when bids are opened; and

WHEREAS, the Commissioner of Public Works requests that Capital Project Nos. 392 through 402 be established and funded in a total amount of \$2,500,000.00 in order to provide HVAC/Weatherization replacements/upgrades to various County buildings; and, now, therefore, be it
