WHEREAS, Ulster County Area Transit (UCAT) is a designated recipient of FTA 5339 funding and annually receives Urbanized Area Formula Program assistance authorized in the form of 5339 funds; and

WHEREAS, funding from this grant would allow UCAT to use these funds to purchase (4) Cutaway Buses at a cost of \$132,347.00 per bus with a total commitment of \$529,388.00; and

WHEREAS, the total cost will be borne up to the following: Federal Share (\$423,510.00), New York State DOT Share (\$52,939.00) and Ulster County Share (\$52,939.00); and

WHEREAS, funding from this grant would allow UCAT to use these funds to cover Preventive Maintenance Expenses with a total commitment of \$462,096.00, until all funds are expended; and

WHEREAS, the total cost of \$462,095.00 will be borne up to the following: Federal Share (\$369,677.00), New York State DOT Share (\$46,209.00), and Ulster County Share (\$46,209.00); now therefore, be it

RESOLVED, that the Ulster County Legislature hereby supports the grant application to the FTA for 5339 Funds; and, be it further
