Chair Obijiski called the meeting to order at approximately 5:20 and lead the Pledge of Allegiance. He made several housekeeping announcements then asked each of the Commissioners to introduce themselves.

Morey Gottesman, Gardiner – President of Friends of Tillson Lake. He noted that Gardiner has unique challenges and opportunities such as a luxury resort and state park. He was concerned that the town was divided in a previous map submission but pleased to see it was whole in the map presented.

Alex Danon, Shawangunk – Shawangunk Town Board. He noted that Shawangunk is also unique and was pleased that this map only divided the town into two districts with one of those districts completely in the town thereby insuring that the town would have at least one representative who lived in the town.

Carol Nolan, New Paltz – She expressed her gratitude to the Commissioners for their hard work and cooperation and said she was proud to live in Ulster County.

Jeff Collins, Woodstock – He shared a small correction of a micro-district of 17 that needed to be corrected. He also shared a proposed change to the Plattekill area that would keep the town in two districts rather than three with one district entirely within the town. He noted that this new proposal would encompass a larger Hispanic population that did not discriminate against and racial or language minority groups.

Betty Diorio, Plattekill – She expressed concerns that the map presented divided Plattekill into 3 legislative districts and supported the changes to the map offered by Mr. Collins.

Gladys Figueroa, Plattekill – President of the Plattekill Latino heritage Association. She asked the Commission to consider the changes offered by Mr. Collins.

Supervisor Mike Baden, Town of Rochester- He had attended most of the Commission meetings and thanked them for their hard work. He supported the changes offered by Mr. Collisn.

Thomas Kruglinski, Gardiner – He expressed his appreciation for the Commission's efforts over the past two weeks and apologized for his intemperate comments a few weeks earlier.

Chair Obijiski thanked the attendees and announced that the Public Comment would remain open for 24 hours. He invited written comment be emailed to Redistricting@co.ulster.ny.us or hand delivered to the Commission on Reapportionment in care of the Legislative Office on the 6<sup>th</sup> floor of the County Office Building at 244 Fair Street in Kingston. He announced the next meeting was scheduled for December 29<sup>th</sup> at 5:15.

## Comments on Draft Map 12-21-2022

## COMMENT 1

# There is an error in the boundary between Legislative District (LD) 9 and 12.

The Draft Map appears to inadvertently put a tiny US Census block of 17 people who live in the Town of Plattekill into LD9.



This can be corrected, while maintaining the size of LD9 (more or less) by moving that US Census block from LD9 into LD12, and moving a small block from LD10 into LD9.

LD9 goes down to -2.41% of mean after moving the Town of Plattekill block into LD12. If the block shown in light red below (which is on the outskirts of Highland in LD10) is moved into LD9, LD9 can easily stay within the sizing requirements.



Making this adjustment, the sizes of LD9 and LD10 are changed to:

#### **COMMENT 2**

The Hispanic Community in the southern half of the Town of Plattekill should be kept in a single district.

Of Plattekill's 10,441 residents, 2,061 are identified in the US Census as being of Hispanic origin (19.7%). **Just over three-quarters of these Hispanic residents**, **1,557, live in the lower half of the town** (shaded in red below).



In the Draft Map, these 1,557 residents are divided into LD11, LD12 and LD16.



According to Municipal Home Rule Law, the top priority is to keep districts within the sizing requirement. The second highest priority is not drawing districts that discriminate against racial or language minority groups. Dividing Plattekill's Hispanic Community as shown in the map above is unfair to this community. This proposed revised map of LD12 and LD16 keeps the Hispanic Community in the lower half of the Town of Plattekill intact, while meeting the district sizing requirements. It also keeps the hamlet of Clintondale intact.



District Changes if this map is adopted (and assuming the boundary between LD12 and LD9 is corrected as per Comment 1):

- LD11 pop. 7,694 121 below mean (-1.55%)
- LD12 pop. 8031 216 above mean (2.76%)
- LD16 pop. 8025 210 above mean (2.69%)

In this revised map, The difference between smallest and largest district of the full map if Comment 1 and Comment 2 are adopted meets the sizing requirement, at 381 people (4.87% of mean).

- LD9 smallest district at pop. 7,650 165 below mean (-2.11%)
- LD12 largest district at pop. 8031 216 above mean (2.76%)

Splitting Esopus into 3 districts (we already have 2 as they took Rifton away 10 years ago and added it into New Paltz) is not fair to Esopus.

Being involved in Town Government for 10 years, I know that our town (composed of 9 hamlets), due to geography and low population density, has left

many people in the southern part of the Town feeling left out. That includes ED 3, 7 and 6. We have been working on ways to help the folks who live in Rifton (ED 4) Union Center, Esopus, West Park and Ulster Park feel included. Many of these people who live in those hamlets have expressed the feeling that the Town only cares about Port Ewen (which is the major part of where our population lives). It's not fair to further isolate the folks in West Park, Union Center, Esopus and Ulster Park and force them to be represented by an official from the Town Of Lloyd that they don't know.. They don't identify with the Town Of Lloyd.

I see that the committee noticed that it's not good to cut up the Town of Plattekill, but I guess cutting The Town Of Esopus into 3 districts is fine? They just don't care about the Town Of Esopus???
