Chairman of the Social Services Committee, Mary Wawro, and Deputy Chairman Hector S. Rodriguez offer the following:

WHEREAS, pursuant to Section C-11(O) of the Ulster County Charter and Section A2-5(15) of the Administrative Code, the Ulster County Legislature shall have the power to approve the execution of certain contracts and amendments in the amount of \$50,000.00 or in excess of \$50,000.00 entered into by the County; and

WHEREAS, a contract for execution by the County with Family Services Inc. has been submitted for approval by the Ulster County Legislature, which is described below:

Department of Social Services	Family Services Inc	Agreement to provide the Intensive Family Education Program which is an intensive home-based parent education and supportive counseling services program for Ulster County families with the highest risk of having a child placed outside the home, or that are in need of intervention and stabilization due to a current crisis.
