WHEREAS, all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to the Budget; now, therefore be it

RESOLVED, that the Ulster County Legislature hereby approves the Budget, as filed with the Clerk of the Legislature, in the amount of $\$ 28,459,575$ providing for a contribution by Ulster County in the amount of $\$ 6,400,863$,
