WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Planning; and

WHEREAS, Ulster County was the recipient of a Community Development Block Grant (CDBG) administered by the New York State Office of Community Renewal; and

WHEREAS, participation in this program requires two public hearings; the first being to seek direction and comments on the application for funding and the second held during the course of the program activities to allow the public the opportunity to comment on its implementation; and

WHEREAS, the County held the first of two required public hearings on the Ulster County Housing Rehabilitation and Disaster Relief Program on December 10, 2013; and

WHEREAS, the County, through its sub-recipient RUPCO, is in the process of implementing the CDBG funded Ulster County Housing Rehabilitation and Disaster Relief Program for which the second public hearing is required; now, therefore be it

RESOLVED, that the Chairman of the Ulster County Legislature is authorized to call such public hearing no later than December 19, 2014; and, be it further

RESOLVED, that the Clerk of the Ulster County Legislature shall cause a legal notice of said public hearing to be published according to law; and, be it further

RESOLVED, that the Clerk of the Ulster County Legislature shall provide a copy of the written notice of hearing to all municipalities within Ulster County,
