RESOLVED, that the Chair of the Ulster County Legislature is hereby authorized to sign an agreement, and any amendments thereto, with the Onteora Central School District to provide two Deputy Sheriffs to serve as School Resource Officers for the term September 1, 2025 through June 30, 2026, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney,

and move its adoption.
